The parties shall share the mediator's fee and any filing fees equally. This Agreement shall be subject to and interpreted under the Federal Arbitration Act.

If credit is granted, Garden State Highway Products, Inc. may suspend or terminate credit to Applicant at any time, for any reason, or for no reason at all, without incurring any liability to Garden State Highway Products, Inc.

Should any provision of this Authorization be finally determined to be invalid, illegal or unenforceable, said provision shall be deemed amended to the least amount necessary to render the provision valid, legal and enforceable, without affecting any of the other terms and conditions.
